- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria". If the bidder is OEM of the offered products, it would also be exempted from the "OEM Average Turnover" criteria. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria". If the bidder is OEM of the offered products, it would also be exempted from the "OEM Average Turnover" criteria. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the

date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Scope of Supply

2. Certificates

Special Instructions to bidders

The bidders are advised to visit the site before submitting the tender to acquaint themselves with the site conditions, working conditions, approaches, estimates, availability of other facilities. The bidders must take prior appointment with IT department of IIM Indore (itdept@iimidr.ac.in, 0731-2439640/641) for the same.

Work completion period

The work shall be carried out within a period of three week from date of acceptance of work order with all due diligence and to the entire satisfaction of the IT department of IIM Indore or to their authorized representative and as specified in the scope of work etc. throughout the stipulated period of the contract.

Technical terms and conditions

- 1. Any civil works such as chipping / digging / cutting of floors/any cemented surface for making grooves, making holes/opening through walls, ceiling, or floors, drilling of holes through steel structures and frames, grouting of frames, hooks on walls/ceiling etc. required for execution of work must be carried out by the bidder. After erection, surface shall be made good by plastering / painting to their original shape and finish.
- 2. The bidder must supply, install, and configure whatever is required to ensure proper functioning of all the supplied items. Whether mentioned in the NIT or not and whether mention in his quotation or not. To Guaranty the proper function of the delivered items as mentioned in the NIT. It will be completely sole and full responsibility of the bidder. All the supplied items have to be integrated with existing network and system by the bidder.
- 3. The bidder has to submit the authorization letter from OEM clearly indicating that the bidder is competent to sell & provide services for all the items mentioned in the Scope of Supply given in this tender document.
- 4. The bidder has to submit the 20 years performance warranty from the OEM for all the installed LAN data points and other passive components.
- 5. The materials shall be moved to the respective place of work within the campus by the bidder.
- 6. All the offered equipment must be properly labeled as required by IIM Indore. The delivered items must be tested and commissioned as per OEM delivered procedures before handing over the project completion.
- 7. Any hardware equipment's required for implementation, those testing, and commissioning procedures is the sole and full responsibilities of the Vendor.
- 8. The bidder should be ready to meet the tender conditions with respect to all activity like supply, installation, commissioning, operation, functioning and testing of all the supplied item etc. The bidder will also integrate them with the existing network and systems.
- 9. The bidder shall be responsible for supply, installation, configuration, Integration, maintenance and operationalization of the supplied items as per IIMI requirement. The bidder will also responsible for functioning and testing of supplied items as per the NIT requirements.
- 10. The bidder shall give warranty for all the supplied items (36 month onsite warranty), conforming to the specified design and there are no defects in the process of manufacturing, packaging, transportation, delivery and installation.
- 11. The bidder has to warrants that the Goods supplied under this NIT are new, genuine, unused, of the most recent or current models and that they incorporate all recent improvements in design and materials unless provided otherwise in the Contract. This warranty shall remain valid for a period of a minimum 36 months (with onsite service support) after the Goods or any portion there of as the case may be, have been delivered, installed, commissioned and date of acceptance by IIM Indore.
- 12. IIM Indore shall promptly notify the bidder in writing/email/telephonically of any claims arising under this warranty. Upon receipt of such notice, the bidder shall, within 24 hours and with all reasonable time, repair or replace the defective Goods or parts thereof, without cost to IIM Indore. If the bidder, having been notified, fails to remedy the defect(s) within the period specified in above, IIM Indore may proceed to take such remedial action as may be necessary, at the bidder's risk and expenses and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.
- 13. The bidder must submit the documentation with network drawings/configuration etc. of all the supplied and configured items to IIM Indore.
- 14. The bidder must provide the Test certificates from the OEM for each item to be supplied.
- 15. The bidder must have highly qualified engineers with qualifications in the network cabling/LAN field and experience working with educational institutes campuses.

5. Generic

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
