(i)	Query	: Clear space between the double glazing of 5mm each in Glass partition.

	Clarification	: Please refer vol-I'A' & vol-I-'B' where it has been discussed in length.
(v)	Query	: Is it mandatory to provide documentary evidence of Govt. work of value 40% along with the other criteria laid down in clause 3.14.1-c(i).
	Clarification	: yes, the intending tendered has to produce evidence of One completed work of any nature (either part of c-(i) or a separate one) costing not less than the amount equal to 40% of the estimated cost put to tender with some Central Government Department / State Government Department / Central Autonomous Body/ State
		Autonomous Body/ Central Public Sector Undertaking/ State Public Sector Undertaking /City Development Authority / Municipal Corporation of City formed under any Act by Central/ State Government and published in Central /State Gazette.
